NEW OR USED ATV/SNOWMOBILE PURCHASED FROM DEALER

REGISTRATION IS COMPLETED
BY DEALER

USED ATV/SNOWMOBILE – Sale between private parties (Previously registered)

Iowa Registered – registration does NOT need to be current to transfer ownership but a \$5 penalty may apply (see Used Vehicle Fees chart)

- Registration receipt or screen print from an Iowa County Recorders office
- Title signed by seller **
- Bill of Sale signed by seller listing purchase price. Sales Tax will be collected on the purchase price.
- Application for Registration (obtained at local County Recorder's office)

****If the Title has a notation regarding a lien, the lien MUST be released by the County Recorder listed on the title.**

Registered Out of State –

- Need Registration and/or Title from previous state signed by seller
- Bill of Sale signed by seller listing purchase price. Sales Tax will be collected on the purchase price.
- Application for Registration (obtained at local County Recorder's office)

ATV/SNOWMOBILE NEVER REGISTERED IN ANY STATE:

Contact your local County Recorder or the Iowa Department of Natural Resources at 1-515-281-5918 for instructions.

NEW VEHICLE FEES:

Between Jan 1st thru Dec 31st, to end of current year:

\$16.75 + Title and/or Lien Fees

Between Sept 1st thru Dec 31st, to end of following year:

\$21.75 + Title and/or Lien Fees

Sales tax will be collected on purchase price.

TITLE FEES:	\$10.50
LIEN FEES:	\$10.50

USED VEHICLE FEES with Current Registration:

Same as new fees listed above

Expired Registration:

Between Jan 1st thru Dec 31st, to end of current year: \$21.75 (\$5.00**penalty, \$16.75 registration fee) +Title and/or Lien Fees

Between Sept 1 thru Dec 31st to end of following year: \$26.75 (\$5.00** penalty, \$21.75 registration fee) + Title and/or Lien Fees

Sales Tax will be collected on purchase price.

TITLE FEES:	\$10.50
LIEN FEES:	\$10.50

****A used vehicle in possession of a Snow/ATV dealer when registration expired will NOT pay the \$5.00 penalty fee.**
